

Terms and Conditions

This IHG® Business Rewards Complimentary Meeting Room Offer and the Booker Bonus Triple Points Promotion are subject to the standard IHG Business Rewards Membership Terms and Conditions and earning structure, which can be obtained by visiting ihg.com/businessrewards. Any Capitalized terms used herein and not specifically defined shall have the meaning ascribed to them in the IHG Rewards Club Membership Terms and Conditions.

“Booking Period” for Offer and Promotion: September 1st, 2019 and February 1st, 2020

“Stay Period” for Offer and Promotion: September 1, 2019 to December 31, 2020

“Group” is considered 10 or more guest rooms per night

Complimentary Meeting Room Offer:

To participate in the Complimentary Meeting Room offer (“Offer”), you must be an IHG® Business Rewards Member, have accepted the IHG Business Rewards Program Terms and Conditions (www.ihg.com/businessrewards), and registered your Membership number for the Offer (“Registration”). Upon Registration, Members will be able to receive, upon availability, a complimentary meeting room. The Offer is available to Groups who have booked during the Booking Period and consumed during the Stay Period. The Complimentary Meeting Room Offer must be included in the contract, at the time of contracting. Offer is eligible for IHG Business Rewards members. Additional terms regarding food and beverage may apply for Offer for participating hotels.

Complimentary meeting space is valid only for one meeting room with standard meeting set up provided by the selected hotel; charges may apply for additional set ups where required. Complimentary Meeting Room does not qualify for any IHG Rewards Club Business Rewards points. Complimentary space is subject to 10 or more consumed guest rooms and to meeting space availability. Triple Points Booker Bonus Promotion (“Promotion”):

To participate in the Promotion, you must be an IHG® Business Rewards Member, have accepted the IHG Business Rewards Program Terms and Conditions (www.ihg.com/businessrewards), and registered your Membership number for this Promotion. Upon Registration, Members will, subject to these terms and conditions, earn Triple Points (9 Points for every \$1 USD Spend instead of 3 Points) on Qualifying Spend booked during the Booking Period for stays and events consumed from September 1, 2019 to December 31, 2020 (“Promotional Period”).
